Anderson & Associates on the basis that it does not meet the requirements of Act 205. Motion carries 4-3. (Sigda, Gross & Reeves voted No.)

Motion made by Mr. Wilson; 2nd by Mr. Sprague to void Council's vote of December 9, 2019 to approve the contract with the Eddystone PD (FOP Lodge 27) for failure to comply with Act 205 requirements. Motion carries 4-3. (Sigda, Gross & Reeves voted No.)

Motion made by Mr. Sprague; 2nd by Mr. Yannuzzi to reject what is now considered a proposed agreement between the Borough of Eddystone and the Eddystone PD (FOP Lodge 27). Motion carries 4-3. (Sigda, Gross & Reeves voted No.)
