This application is to be used only for residential projects (1 or 2 Family Dwelling, max. 3 Stories in Ht.), or for permits required by Eddystone Building Code Ordinances established prior to 7/1/1999. (Local requirements remain in effect per UCC Act 92 of 2004) There is a \$50.00 nonrefundable application fee due upon submission of permit.
