VP Councilman Yannuzzi also commented on the great day for Eddystone with hosting the Rite Aid Covid vaccine clinic with our own Eddystone resident Dr. Alex Costa administering the vaccines and will be back on May 26, 2021 for the second shots.

Councilwoman Reeves questioned when the public meeting would be held for RCAP so the residents of Eddystone could find out info on the possible new Municipal Complex. President Stewart answered possibly July once more answers are in so hopefully all could be answered accordingly.

Mayor Reeves relayed to all that St. James held a great Baggo tournament this pass Saturday with 62 teams in attendance.

Mayor also requested Boro signs be accounted for as the borough does not have proper signage to help control the truck problem here in town.

Councilman Sigda questioned the property at 1401 11th Street with parking, EIT 1%, cameras, monitoring of premises, tenants and information as to updates that were to be relayed to the council.

Eddystone Council also commented on the 291 problem with tractor trailers coming out onto 291 and causing a possible major problem and requests attention to this matter.

Councilwoman Gross also stated that Saville is an ongoing problem with Penn Terminals and ongoing back up which makes it difficult for our community and suggests having a cop there would help.

Solicitor Amuso relayed that the Governors orders will be expiring and that future meetings would be in person but he will keep us posted on information received regarding future meetings.
