## Professionals Report, Kelly Engineering: Infrastructure and Capital Projects

- HVAC for Lighthouse Hall (LHH) Contract bids are will be opened and ready for approval at October 13 meeting,
- Flooring contract documents for LHH executed and submitted to OHCD
- 10 Acre Waterfront parcel, JP Kelly and Dr. Moler attended a DEP Zoom meeting on the waterfront site and DEP / Costal Division recommended that Eddystone seek funds for initial planning, they also suggested Eddystone do an Environmental Resource Map, in preparation for such applications, which Kelly & Moler will present a scope for soon.
- Baldwin Towers: seeking zoning relief on parking and height of building. Pending review.
- Sewer cleaning schedule to include 9<sup>th</sup> Street. This is the 3<sup>rd</sup> year of the sewer cleaning. Gas line installation has uncovered 4 sink holes starting. Kelly to investigate.
- Second Street: met with Secretary of Transportation on the project. Spoke about two consecutive grants

# **Ordinances and Legislative Actions**

- Nuisance Property Abatement Ordinance 683-2025: Purpose: Address properties with repeated public safety disturbances or disproportionate municipal resource use. Key elements:
- Definition: Three or more qualifying police responses or ordinance enforcement actions within rolling 12 months, excluding good-faith emergency calls (e.g., domestic violence, sexual assault, medical).
- Process: Notice of determination; right to hearing within 15 business days; hearing within 30 days; borough burden by preponderance of evidence.

- Abatement plan: Security, lighting, lawful lease enforcement, repairs, communication conditions.
- Penalties: Up to \$1,000/day for non-compliance; no penalties for seeking emergency services.
- Non-discrimination: Compliant with constitutional and civil rights laws; severability; effective upon enactment; supersedes prior related ordinances. Approved.

### **Sewer Lateral Ordinance Amendment 684-2025:**

• Change: Validity of acceptable sewer lateral testing extended to one year to allow reuse if a transfer/settlement falls through. Approved. Note: PennVest offers low-interest homeowner loans for lateral repairs/rehab; separate from warranty-style monthly plans.
